Introductory IIOM Presentation to New Attendees including a Case Study Jon Anslow will briefly introduce IIOM to new members and guests before sharing a case study to show how obsolescence works in practice.

<u>IIOM International Update – Wolfgang Heinbach, IIOM International President</u> Wolfgang will update the audience on overseas chapter development, conference development, and other international matters.

Four new corporate members will be invited to deliver short presentations on their business and what their expectations are in joining the institute.

Introduction to a complimentary trade association – Andrew Evans, GAMBICA GAMBICA is the Trade Association for Instrumentation, Control, Automation and Laboratory Technology in the UK. They are a very active organisation engaged in lobbying, representing their members, organising events and contributing to standardisation and environmental efforts to support their diverse members.

Andrew will introduce the organisation and share some of their industry concerns with regards to obsolescence management.

<u>Avoiding Counterfeits in the Safran Supply Chain – Thomas Whitcomb, Safran Electrical & Power</u> Safran expert Thomas will describe their best practice and experiences in managing counterfeit risks in their avionics business.

Reach Update – Terry Rees-Pedlar, BAE Systems

Terry will deliver his regular Reach and environmental legislation update.

<u>Managing Obsolescence as a Global Integrator and Maintainer – Stuart Broadbent, Alstom</u> Stuart will discuss how the rail industry is starting to look at obsolescence (all maintenance tenders now include obsolescence treatment risk transferred to maintainer, for example, and changes to standard trading conditions. Stuart will also discuss what Alstom as an integrator (and maintainer) is doing across its global business.

Panel Discussion – Counterfeits: Are we really managing the problem? Experts from IIOM and other invited guests will discuss questions from the audience. The experts will be able to cover: Recommended best practice and standards MOD best practice and industry guidance applicable to any sector Reporting and information sources Testing and inspection of suspected devices Legal position following receipt of counterfeits
